OSIsoft Applicant Tracking System Notice and Request for Consent

Introduction

This Notice/Consent Form explains how your personal data will be processed if you choose to submit information through OSIsoft's applicant tracking system ("ATS") (accessible through the "Careers at OSIsoft" section of OSIsoft's web site), and how you can exercise your rights with respect to that processing. This Notice/Consent Form does not apply to any other processing of your personal data by OSIsoft or any of its affiliated companies.

OSIsoft's corporate headquarters are located at 777 Davis Street, Suite 250, San Leandro, California, in the United States.

Consent to Collection and Use of Personal Data

1. Purpose of Personal Data Processing

OSIsoft uses the ATS globally to manage on-line job applications received from current and prospective employees and to provide job opportunities in the country where you are about to apply as well as in other countries and regions. The ATS is provided through Peoplefluent, a third-party service provider. If you choose to use the ATS and provide your consent, OSIsoft may use your personal data to (i) to help us collect and compile additional information about you from available sources, consistent with applicable law, (ii) to contact references which you provide us; and (iii) to evaluate your application for employment for the position for which you have applied and for future positions.

2. Items to be Collected

(1) Through Peoplefluent, OSIsoft will collect the following information that you provide in the application form as well as any other information that you may provide on an application in connection with a specific job posting (the "Personal Data"):

Position or position area applied to, name, date of birth, nationality, address, e-mail address, telephone number (home, office, and mobile), work eligibility, family members (name, occupation and position, contact information), educational background (school name, major, year of entrance and year of graduation, graduation status, GPA, etc.), work experience (type of employment, company, title, responsible area, date of commencement of previous employment and date of termination, causes of termination, period of employment, salary (proof of income, etc.), licenses (type, date of licensure, issuer), language ability, computer utilization ability, available date to commence employment, military service record, reference contact information, and any other voluntary entries, detailed descriptions of career, family background, reason for application, future aspirations and any other voluntary entries.

(2) OSIsoft will collect the following information that you provide at the time of interview:

Communication skills, interpersonal relationships (relationships with superiors/colleagues), leadership positions held, decision making skills, training, career development path, career goals, problem solving skills, conflict management skills, creativity, customer-orientation, time management, delegation of authority, responsibility/role, morality/ethics, job performance ability, integrity, credibility, attentiveness, motivation, negotiation ability, organizing ability, self-improvement efforts, planning ability, drive, analytic ability, presentation ability, process management, strategic thinking ability, interpersonal perception ability, etc.

3. Retention of Your Personal Data

If you are offered and accept a position with OSIsoft, your Personal Data will be included in your Human Resource file and retained by OSIsoft's Human Resource department for the term of your relationship with OSIsoft and for any post-termination period permitted or required by applicable law.

If the application process does not result in your employment by OSIsoft, your Personal Data will be kept for three (3) years after consideration of your application is complete, unless you inform us that you would like us to retain your information for a longer period. Alternatively, you may request OSIsoft to delete your Personal Data and OSIsoft will promptly comply with such request.

4. Your Right to Refuse to give Consent /Disadvantages

Please note that completing the application form and giving your consent to the processing of your Personal Data is voluntary, but without your consent, OSIsoft cannot proceed with the review of your application. International Transfer of Your Personal Data

1. Recipient and Purpose of International Transfer of Personal Data

Your Personal Data will be transferred to, and maintained by, Peoplefluent, with corporate headquarters located at 434 Fayetteville Street, 9th Floor, Raleigh, North Carolina 27601, in the **United States**. Peoplefluent will process your Personal Data, subject to OSIsoft's instructions and only for the purposes stated in this Notice/Consent Form. Because OSIsoft is a global multinational company, your application will be used globally in connection with recruitment processes within the Company. Therefore, your Personal Data may be transferred across

national borders and may be accessed by Company affiliates from countries with different laws providing varying degrees of protection for your Personal Data. Please refer to OSIsoft's web site www.osisoft.com for the location of corporate affiliates. OSIsoft will not disclose your Personal Data to any third party who is not (a) a member of the Company's corporate group, or (b) a service provider under written contract, without first providing you with notice and obtaining your affirmative consent.

When the Data is transferred over the Internet, it will be protected by a secure transmission protocol (128-bit encryption).

Your Rights

You have the right on your own initiative to, among other things, access, modify, supplement or update the Personal Data submitted. You can access your Personal Data through the "Careers at OSIsoft" section of OSIsoft's web site using the credentials you created during your initial submission of Personal Data. You also may use this address to revoke your consent to processing your Personal Data. Any revocation will apply only prospectively, and we will continue to retain the information that you provided us before you revoked your consent for as long as permitted or required by applicable law
